(B) Cancellation of the Membership


1. If he/she dies, resigns or mentally victim of disorder us become handicapped

1) Every decision regarding any bill or subject is to be pass by majority votes of member of society at present in meeting.

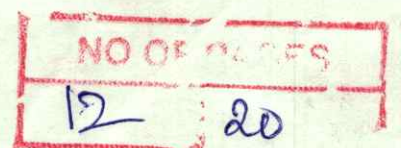


10. Managing Committee and its Constitution:


1. The Ex.Officio-member shall preside over the meeting of the Managing Committee.



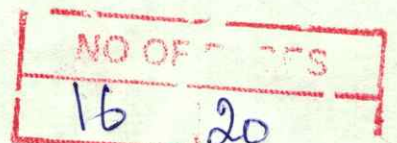

13.Meeting of the Managing Committee and Meeting of requisition

1. Meeting of the Managing Committee shall be called for once in 3 (three) months.
2. The president shall also call a meeting of the Managing Committee on the request made to him in writing by any 3/5 (three fifth) of its members of the Managing Committee, specifying the purpose for which such meeting is desired to be held within 15 days from the receipt of the demand application. The requisitions may themselves call a meeting, with issuing of notice to the members of the Society minimum 15 days before such meeting and the details of date time and place and reasons of the said meeting. The rules were followed of the Annual General Meeting.
4. Notice of the requisition meeting of the Managing Committee be given at least 48 hours before the meeting of Managing Committee.
5. The Managing Committee can invite the persons who are the useful to the society by the permission of the president but they have no right of voting.

The Managing Committee have right to appoint a Sub-Committee. 16. Provisions for Objective Expenditure (with the percentage)




22. Dissolution
