6. Both the parties will undertake all the feasible measures for promoting the activities of the other party.



**IV. Confidentiality and Media Release:**

"Confidential Information" means any and all information relating to the business or to the affairs of a disclosing Party which is not generally known including without limitation, trade secrets, know-how, data processes, designs, formats, reports, specifications, software programs, samples, rates, pricing terms, client lists, details of suppliers, details in respect of other employees of the disclosing Party, market survey information, the identity of clients or their requirements, the identity of key contacts within client organisations, marketing and merchandising techniques, methods, processes, formulae, compositions, systems, techniques, inventions and all writings and materials of any type embodying any of such information which is marked with an indicator such as "Confidential" or "Proprietary", but excluding information which:
  - a. is or comes into the public domain otherwise than by disclosure or default by the recipient Party;
  - b. was or is lawfully obtained or available from a third party who was lawfully in possession of the same and free to disclose it; or

2. **Media Releases and Dissemination of Information:** All communication with media entities, or sharing of information on social media platforms, with respect to information about the Project, will be undertaken solely by LCF or jointly between LCF and the Program Party. The Program Party shall not make any disclosures in furtherance of the LOU, with any third Parties, or on third party platforms, without obtaining the prior written consent of authorized officers of LCF.

**V. Intellectual Property Rights:**

1. Parties agree and understand that LCF shall have complete ownership rights, title and interest in the course material and curriculum designed and shared with the Students and/ or the Program Party, as deemed necessary by LCF, in furtherance of this LOU, including without limitation intellectual property rights thereunder.
2. Each Party shall at all times be the sole and exclusive owner and/ or be deemed to own or have rights in respect of all intellectual property rights in or to its products, equipment, services, systems and any derivative works of or improvements, enhancements, modifications or updates thereto, which existed before or on the date of this LOU, and thereafter, if the same does not relate with or has been created in furtherance of this LOU.

**V. Termination**

- 6.2 Both parties undertake to each other to keep confidential all information (written or oral) concerning the business and affairs of the other, which has been obtained or received during the course of performance hereunder, save that which is:
  - a) Inconsequential or obvious;

  - c) In the hands of the public other than as a result of a breach of this clause
- 6.3 In the event of any of the parties becoming legally compelled to disclose any confidential information, such party shall give sufficient notice to the other party so as to enable the other party to seek a timely protective order or any other appropriate relief. If such an order or other relief cannot be obtained, the party being required to make such a disclosure shall make the disclosure of the Confidential Information only to the extent that is legally required of it and no further.

## 9 Headings

9.1 The Headings used under in this MoU for a group of terms and conditions are meant to serve only as a convenience. The Headings are not to be considered for the interpretation of terms or conditions in the MoU.

## 10 Validity

- 10.1 This MoU embodies the entire, sole and exclusive MoU and understanding between the parties hereto with respect to the subject matter hereof.
- 10.2 Any amendment or modification or waiver in connection with this MoU will not be effective unless made in writing and signed by both the parties.
- 10.3 If any provision of this MOU is held to be invalid, illegal or unenforceable, the validity, legality and enforceability of the remaining provisions hereof shall not in any way be affected or impaired thereby.
- 10.4 This MOU shall be effective from January 01, 2017 and shall be valid till December 31, 2017 from the effective date, unless terminated earlier. This duration can be extended further with mutual consent.

## 11 Waiver

- 11.1 The party that is entitled to the benefit hereof may waive any term or condition of this MoU at any time. Such waiver must be in writing and must be executed by an authorized officer of such party. A waiver on one occasion will not be deemed to be a waiver of the same or any other breach or non-fulfillment on a future occasion.

## 12 Force Majeure

- 12.1 Neither party to this MoU shall be liable for any failure or delay on its part in performing any of its obligations under this MoU if such failure or delay shall be result of or arising out of Force Majeure conditions and, provided that the party claiming Force Majeure shall use its best efforts to avoid or remove such cause of non-performance and shall fulfill and continue performance hereunder with the utmost dispatch whenever and to the extent such cause or causes are removed.
- 12.2 Any extraordinary event, which cannot be controlled by the parties, shall for the purpose of this MoU, be considered as a Force Majeure event. Such events include natural calamities, acts or omissions of any University or agency thereof, compliance with rules, regulations or order of any University Authority, strike, lockout, unlawful acts, willful tampering of data on the portal and hardware and power failure, downtime of ISP services, virus/worms/spyware/denial of service attacks, spamming and hacking attacks. PROVIDED however, if either party claims that existence of any of the aforesaid conditions is delaying or disabling the performance by said party of its obligations under this MoU then such party shall give immediate notice by registered mail or courier to the other party of the existence of such conditions whose existence are claimed to delay or disable the performance of obligations as aforesaid.


## 13 Termination

- 13.1 The MoU can be terminated by either party giving the other party, a prior written notice of not less than three months of its intention to do so but without dishonoring any commitment entered into prior to the date of termination notice and no party shall leave its commitment unfinished which may result in tangible losses to the other party.
- 13.2 The MoU shall also stand terminated for any reasons such as legal processes, acts of the State or similar such exigencies beyond the normal control of the party concerned and which disable any of the parties hereto from functioning further.

RAYAT SHIKSHAN SANSTHA and "TCS" are hereinafter collectively referred to as the "Parties" and individually as "Party" as applicable.
